Upon a motion by Director Fuller and seconded by Director Ward the Board approved entering into the Tri-District Joint Powers Agreement between Exeter ID, Ivanhoe ID, and Stone Corral ID, providing for the establishment of a separate agency for the employment of a common General Manager.

There was nothing new to report on the Five-Year Water Management Plan.

The Board agreed to send a bulletin to the Landowners regarding the use of allocated water for the 2021 season.

Upon a motion by Director Crosson and seconded by Director Fuller the Board approved and adopted the resolution to continue to hold meeting via teleconferencing.
